FIRST SESSION June 24, 2022

The **1**st **Session** of the 2022 Department Convention was called to order at 9:10am by Convention Chairman Carol Pickett. Linda Marshall, acting Chaplain for this Convention opened the Bible and placed it on the table in front of the Podium.

Carol asked everyone to turn off their phones, show respect, no talking and if your phone rings, the Ways & Means Chairman Bonnie Rojeski will collect \$1. Bonnie said she will collect \$5 if it rings a second time. (It looked like everyone was turning off their phones!!)

Carol asked the Sgt-at-Arms Clarice Poisson to escort the Department President Cel Rose Solak to the convention floor.

The invocation was delivered by acting Chaplain Linda Marshall.

The Pledge of Allegiance was led by Sgt-at-Arms Clarice Poisson...

There were 6 delegates registered, 16 Dept. Officers, 3 PDPs, for a total of 26 registered, 24 total votes. Majority is 13 and 2/3's vote is 16.

Convention Rules were read by Parliamentarian Pat Michalski.

**Motion Pat Michalski/2nd Kathy Keizer to adopt the convention rules as read. CARRIED

REPORTS

President Rose stated there have been many communication problems this year from the AMVETS and some of the Auxiliary Officers. This year's voting is most important. The President also asked everyone to attend the joint opening and the Americanism program.

1st Vice President Kathy Keizer turned in her activity report and bulletin for the Convention book. She reported there was one local Auxiliary which was 100% renewed by the 10/31/2021 deadline. Congratulations to Auxiliary #115. Their \$25 prize has been sent and their certificate will be mailed after convention

The other contest is the Early Bird Renew Yourself contest for those who renew starting July 1 until October 31. The SEC voted to approve \$200 for this contest – this year only. The winners are \$50 – Marsha Vaughn, #1957 and \$25 each for the following: Lois Bailey #115; Joan Maciejewski #22; Carol Hunter #115; Sarah Velasco #57; Phyllis Ann Will #115; Judy Cardew #122.

Kathy also gave a recommendation to the Honors & Awards Chairman about changing the membership numbers for each of the 3 Membership Awards to more even the field and give more locals an opportunity to win.

There was an increase of 9 members over last year's totals. However, we failed to renew 206 annual members. If we are going to grow and have ladies interested in getting involved, we need to renew those annual members. She is worried about the future of the Department. We only have four announcing for Offices so far.

Certificate were passed out for 100% renewal and/or equivalent by June 1, 2022. They were #23, #52, #115, #72, #79, #93, #110, #114, #115, #120, #121, #122, #1957, #1988, #2273, #4064.

2nd Vice President Linda Marshall sent in her Activity report for the convention book. She thanked all the local Auxiliary for their generous donations to Penrickton Center. Kurt Sebaly, Executive Director of Penrickton (and guest at the Auxiliary Department Convention) could not be with us today because his Father-in-law had just passed away. A replacement will be representing him at this convention. A card was distributed for everyone to sign and will be sent to Kurt.

3rd Vice President Allison Aldrich turned in her activity report. She announced Mary Blaine, a representative from PAWS, will be here today with her foster dog. Allison will give out her Chairman's Award this afternoon.

Treasurer Deb Davis did not have an activity report or a finance report turned in for the convention book. She read her activity report and passed out copies. She thanked President Rose, Gloria Hall and the Secretary for their help this year. She announced the Texas Hold'em have been very successful. Deb also pointed out the membership renewals are very important.

Deb presented the 2022/2023 proposed budget as revised and approved by the Finance Committee on Friday. Everyone needs to look over the budget. It will be voted on tomorrow (Saturday).

Americanism Officer Pam Lein has her activity report in the Convention books. She asked everyone to remember the Americanism Awards program. We are expecting many of the winners and their families.

Hospital Officer Kay Kemp has her activity report in the Convention book. She apologized for not attending the S.E.C. on Friday evening. Only one hospital pin was requested from the local Auxiliaries by the deadline date (3/1/2022). It is awarded to Linda Marshall for 1,000 hours. Linda is from Aux. #22.

Scholarship Officer Karen Harmon submitted her activity report which is in the Convention book. There is only one Scholarship awarded this year and it is to Zaiden Mitchell (Post #22)..

N.E.C. Woman Pat Michalski has her activity report in the Convention book. She sent all the National Reports in time and copies are also in the Convention book. She still has some National Raffle Tickets for sale - \$5 for 6 tickets. This is a very large drawing at the National Convention and the winning daily tickets could be for several hundred dollars.

Honors & Awards Bert Lema turned in her activity report. She stated there were a lot of problems this year and we were like a dysfunctional family. Many Auxiliaries sent in final reports – but no midyear reports. Some sent in midyear reports but no final report. Some sent in both but did not make Department donations per Donor's Rules. It is important to send reports to keep our non-profit status.

The 1st Vice sent in a suggestion to change the Auxiliary size on the three Membership Awards. The suggestion is Class A-81 and over membership; Class B 51 to 80 membership; Class C 10 to 50 membership

Personnel Committee, Chairman Allison Aldrich turned in her activity report. The Committee has suggested a raise for the Department Secretary since she hasn't had one for a few years. The suggestion was forwarded to the Finance Committee. The proposed budget will be passed out this afternoon and we will vote on it tomorrow.

Ways & Means Bonnie Rojeski said the Texas Hold'ems were very successful. She thanks all those who worked them. Fundraising at Fall Conference was fairly light. It is also light at this convention because we don't have a lot of people. Bonnie asked for a 5-minute break to sell tickets for gift cards. Bert noted that at National Convention sellers walk with a sign stating the price of the tickets. Delegates hold up their money and there is no disruption or talking.

President Rose drew the winners of the gift cards - #1 Karen Rapp and #2 Clarice Poisson.

Parliamentarian Pat Michalski announced she received news about Aux. #114. The President, Secretary, Treasurer and Parliamentarian all resigned. This would put #114 in the "Not in Good Standing" category.

Sgt-at-Arms Clarice Poisson did not turn in an activity report but did write a bulletin for the Convention Book. She said she was just on the job since the Spring SEC. This is a busy job and she hopes someone is interested in taking it.

Higgins Lake Lodge Rep Roberta Robinson turned in her activity report. There have been a lot of challenges this year which still need to be met.

Convention Chairman Carol Pickett turned in her activity report. She thanks the President for the appointment and she is happy to be here. The year was difficult. The Commander apologized to her and gave her a hug. Let's move on – this year has been difficult for everyone.

Carol brought in a Convention book from 1998 – the first time President Rose was the Dept. President. There was also a copy of the Convention Newsletter. This was a newsletter put on the Convention tables every morning. It highlighted event of the previous day and some funny things which happened. Carol also thanked the Secretary for giving her a "Stress Ring" which is supposed to relieve stress to the wearer.

To add to Carol's stress, the phone in her room is not working. She gave everyone her cell number. She has never met the AMVET Convention Chairman. There is no information about the banquet. President Rose said it is casual dress.

Fall Conference Bert Lema turned in her activity report. She stated those who attended had a ball. Faye Richardson-Green and Pat Michalski did great instructions on Leadership and Service program. If we do another Fall Conference along with the Auxiliary weekend maybe Deb Davis and Kathy Biela need to be separated. (Note: no explanation, but a lot of laughter)

PRO/Historian Kathy Biela filled in for Kathy Jo Johnson. Kathy reminded everyone to send picture of local events to Kathy Jo.

Website Pat Michalski, Webmaster: Back when we started the website there was a lot of stuff sent in. Now it is difficult to get bulletins from anyone. Aux. #93 sends pictures but no information is sent. At the Spring SEC, Deb Davis offered to help (and then had surgery and then went on vacation) We have a By-Law change suggesting the Webmaster be a 3-year term – appointed by the President.

Clarice Poisson said the newsletter should share with the website. She said she goes to the website a lot but there are no bulletins or information from the Officers. President Rose said the Auxiliaries need to advertise their events and share information.

District I President Seletha Robertson has her activity report in the Convention book. She reported District I has voted to disband. Hopefully they can someday come together and be a District again. Seletha stated she is wearing her mask because she has several medical issues and is scared! District I has a candidate for the Office of Treasurer – Deb Davis.

District II President Pat Michalski has her activity report in the Convention book. She stated District II is also disbanding because no one wants to take an office. The District has one candidate for Department Office. Linda Marshall is seeking to serve one more year as Dept. 2nd Vice President.

District V President Nancy Middleton has her activity report in the Convention book. She is happy to report District V is doing well. We had our elections and have a full slate of Officers. We do

events, hold Texas Hold'ems, hold 6 meetings a year – and have money. At our last meeting in May, our Department President and her PRO made a visit. At our meeting, each Officer gave a report, we approved our budget, held our elections and were sworn into Officer – all in 1 hour and 5 minutes.

The District Presidents used to have several duties. Each year they eliminate some of them and the result seems to be lack of interest because there is nothing to do.

District V has two people seeking Dept. Offices: Pam Lein for re-election as the Americanism Officer and Nancy Middleton seeking the Office of NEC woman.

District VII Barb Robare is excused.

VAVS / Michigan Home Reps.

Aleda E Lutz VAVS Linda Marshall has her report in the Convention book. They are starting to get Bingo back at the VA. Linda has \$204.06 in her checking account and \$499.20 in savings.

Ann Arbor VAVS Pat Krzesowik – excused

Battle Creek VAVS Faye Richardson-Green has her activity report in the Convention Book. Faye talked about a rumor that BCVA is closing. The answer is Yes and No. The plan to close is way in the future – at least 10 years before the plan goes into effect. Right now her duties at the VA is a Greeter. She interacts with outpatients and she loves it. There are some events planned in the future. Faye does them jointly with the ladies from the VFW

She has \$236.94 in her checking account. There is a big problem with Huntington Bank. They have been taking \$40 per month out of her account since January. Faye is trying to get this money put back in the account.

Sgt-at-Arms Clarice Poisson complained because we have too many people coming to the podium and they are cutting the Colors.

Michigan Veterans Home - Grand Rapids Clarice Poisson had her activity report in the Convention book. She said the Home is not yet open to volunteers. She has \$255.07 in her savings account. She thanked Auxiliaries #23, #57, #126 and #4064 for their donations. She sent \$1,000 to be used for flowers and plants.

The Dept President visited the Home in May. Leora Williamson, Deputy, sent up the visit.

Treasurer Deb Davis had the proposed budget passed out and went over some of the changes by the Finance Committee which were not on the printed sheet. The Convention. Body will vote on the budget for 2022/2023 tomorrow.

We broke for lunch at 11:11am

Resumed 1st session after lunch.

Guest Mary Blaine and her gorgeous 6-month-old Golden – Scout. 3rd Vice Allison Aldrich presented Mary with a check for PAWS in the amount of \$8,152 which is the amount collected from our local Auxiliaries for 2021/2022.

Parliamentarian Pat Michalski distributed copies of the By-Law Committees suggested changes. Everyone should read them tonight. We will vote on them during the Saturday Session.

Treasurer Deb Davis received a receipt from Linda Marshall for supplies in the amount of \$44.46. The budget for supplies is \$10. She purchased files and file boxes to keep the 2nd Vice records in. This is overbudget by \$34.46.

**Motion Deb Davis/2nd Bert Lema to pay Linda Marshall the entire \$44.46. CARRIED This will have to be \$10 from the 2nd Vice budget and \$34.46 from miscellaneous.

NEC Woman Pat Michalski brought a resolution to the floor which the Americanism Committee wants sent to National.

Resolution from the AMVETS Ladies Auxiliary Department of Michigan

WHEREAS: The National AMVETS Americanism Flag Drawing, Poster and Essay Contest exists to support teaching students in grades K-12 about Americanism, patriotism and civic responsibility AND

WHEREAS: Said contest has historically provided Departments and locals with an annual theme and specific prize awards for national winners at 1st, 2nd and 3rd place AND

WHEREAS: The national programs staff abruptly deleted specific prize levels without notice to the Departments and it was discovered recently paid out prize awards were significantly lower than advertised AMD

WHEREAS: Current prize awards are now communicated vaguely as: 1st place winners to receive a plaque and unspecified gift card amount. 2nd place winners to receive a certificate and unspecified gift card amount; and 3rd place winners to receive a certificate and unspecified gift card amount AND

WHEREAS: Such gift card amounts to range between \$10 and \$250 and determined for winners after the contest closes and total entries have been calculated.

THEREFORE: The national contest prize awards are filled with uncertainty and lack incentive for potential entrants. Neither the Departments nor students entering the contest will know what the competition actually pays at the time of contest entry until all entries are judged and thew winners are announced.

BE IT FUTHER RESOLVED: The National AMVETS Americanism Flag Drawing, Post, and Essay Contest for K-12 students be re-instated and a prize list be published which specifies specific gift card dollar amounts for each grade level and winners at the 1st, 2nd and 3rd position

SECOND SESSION June 25, 2022

The 2nd Session of the Auxiliary convention was **called to order** at 9:00am by Convention Chairman Carol Pickett.

The invocation was delivered by acting Chaplain Linda Marshall.

The flag was presented by Sgt-at-Arms Clarice Poisson

Roll Call of Officers by Secretary Nancy Middleton showed all in attendance with the exceptions of Ann Arbor VAVS Pat Krzesowik, John Dingell VAVS Maureen Jackson, Jacobetti Home Rep Judy Smith, District VII President Barb Robare – all excused.

Credentials Report by Karen Harmon: Total registered 28 / total vote 27. Majority is 14 and 2/3's vote is 18.

Treasurer Deb Davis – discussed some changes for this year in the proposed budget. #1 – mileage increase based on current gas prices. .15 cents per mile if prices are below \$3 a gallon. .20 if prices are between \$3.01 and \$4. .25 if prices are between \$4.01 and \$5. .30 if prices over \$5.01. This will be based on an average of prices in the State of Michigan.

#2 \$200 will be put in the restricted Savings (#1) to be available for the Americanism Officer if she chooses to attend the Auxiliary Seminar at Freedoms Foundation . This would cover the cost of the seminar but would not include mileage, food, etc. The seminar is held every other year and the cost is approximately \$400. This event is for the Dept. Americanism Officer only. If she chooses not to go, the funds will be held in reserve for the next event. The seminar is held every other year (in the odd years: 2023, 2025, 2027, etc.

#3 Secretary's compensation was increased to \$6,000

By-Law Committee Meeting – Department Convention – June 23, 2022

Proposed Changes to Department of MI By-Laws:

W DE A DC

Article V – Section 4- NOW READS:

All newly elected and appointed officers shall assume the duties of their respective office after the close of the

Department Convention except for the Department Treasurer, who shall assume her duties immediately following the Department audit; and the Executive Secretary, who shall assume her duties immediately following the Department audit and the completion of the Convention minutes being posted to the Department website.

CHANGE TO READ:

All newly elected and appointed officers shall assume the duties of their respective office after the close of the Department Convention except for the Department Treasurer, who shall assume her duties immediately following the Department audit.

Delete <u>and the Executive Secretary</u>, who shall assume her duties immediately following the <u>Department audit and the completion of the Convention minutes being posted to the Department website.</u> Executive Secretary is not an officer.

**Motion Pat Michalski/2nd Bert Lema - CARRIED

Article V – Section 5 – NOW READS:
