Reports/Recommendations of the National Officers/Committee Chairman

National President Joan Sirek: Enjoyed visiting the Departments, lost her luggage, thanked the Departments for their friendship & hospitality. Her project to replaced the window in MacArthur Hall at Freedom Foundation. Announced Auxiliary Americanism Conference in October 5–8, 2023. Highlight was visiting the New York 911 Memorial and Museum. Continue to sell tickets for afghan & her project.

National First Vice President Karin Simmons: Announced 9 new auxiliaries. Received reports some auxiliaries have disbanded. Thank Headquarter staff National Executive Director Carol King and Sonja.

Article 111 Duties of Officers:

National Third Vice President Cindy Rice:

Very uplifted year. Selling tickets for quilt, made by Linda Bonin. Sold over \$48,000.00 for PAWS. 23 members at the meeting, brought up several new ideas for fundraising. Blessing Box.

Add; An Honorary member is eligible to receive a blood donor pin. Carried Add: To the convention digest: A one (1) time Blood donor pin will be presented to a member donating the first eight (8) pints (1 gallon) with written verification. Carried

National Treasurer Report: Barbara Guth:

Reporting donations were up by 20%. No third person on Credit Cards, No debit cards, Make sure you have money in your account. Follow deadline dates, there, there for a reason. Do not hold up checks for 60 days. 15 committee members attended. The Treasurer presented the proposed budget to read over.

Article V Standing Committees Section 1(d) Finances:

The National Finance Committee shall consist of the following: National Treasurer, who shall serve as Chairman, National President, ex-officio, NEC Council Chairman, Immediate Past Treasurer, National First Vice President, National Second Vice President, National Third Vice President, Immediate Past National President, ex-officio, with vote, one NEC member elected at Post Convention NEC for one-year term and the National Parliamentarian, ex-official, without a vote.

Recommendation: Since there may not be an immediate Past Treasurer.

Add (e) In the event there is no Immediate Past Treasurer, the President shall appoint a member of the National Executive committeewoman to the Finance Committee. Term to coincide with the National Treasurer. This would then change the current e to d, d to e – etc Carried

National Scholarship Laura Shea:

Theme "Knowledge is Power". 5 members attended, received 30 Scholarships, 23 were disqualify. Sorry could not hear, too much noise.

Add to Scholarship application: PDF verified signatures will be accepted from reference. Carried

Add: An updated check list for Scholarship applications will be included on the National website Scholarship application packet information. Carried

National Hospital Officer: Laura Bugaj:

There were 25 committee members who attended. I attended, served and participated with the committee skit.

Question from Ohio on how VAVS hours should be reported for travel and hours?

Recommended change to the Manual: Where as Page 104 of the manual currently read: National, Department, District or Regional Officers may credit her hours to the Local Auxiliary, when the activity in which she participated involved the duties of the respective office she holds. A member may credit hours to the Local Auxiliary, excluding the VAVS Program.

It is recommended Page 104 of the Manual be changed to read: National, Department, District, or Regional Officer may credit her hours to Local Auxiliary when the activity in which she participated involved the duties of her respective office she holds. A member may credit hours to Local Auxiliary, including the VAVS Program. Carried

This will bring the manual into compliance with, pages 34 and 107 which currently read.

The VAVS Representative or Deputies may credit hours when the activity in which she participated involved the duties of her office, to her Local Auxiliary. Page 34 Carried

Actual hours spent in any hospital or in direct contact with the patient may be applied towards Hospital Pins and Hour Bars. Hours spent in travel may be counted only on Hospital Service Report form. VAVS Representative and or Deputies hours spent at VAVS meetings are to be reported to their Local Auxiliary. Page 107 Carried

Futhermore: this would not constitute "double dipping" in regards to the Joint Annual Review. The Annual Joint Review and Hospital Service Report measure two separate things. The Annual Joint Review gives validation to the Auxiliary having a voice within the VA Veteran Service. The Service Report gives an accounting to the IRS and Congress justifying the Auxiliaries Tax Exempt status. Not including the VAVS volunteer hours and mileage on the Service Reports would give an inaccurate picture of the voluntary evaluation of the Auxiliary as a whole.

Add: \$10.00 Evaluation for wheelchairs/walker bags (no other evaluation). Carried

Department of Michigan resolution was rejected

Conflicting Information: Membership/Rejoin (Manual, Constitution)

Constitution Article IV: Membership and Dues; Section 3

Honorary Membership- Honorary membership are granted in instance where circumstances and/or qualification merit such distinction and shall be limited to ladies who are not eligible for regular membership. Local Auxiliaries may grant one Honorary Membership per year. An Honorary Membership is \$10.00 annually to National Headquarter. Any additional charges to the Honorary Member would be up to the Local Department Auxiliary.

Local auxiliaries may grant two Honorary Membership per year. An Honorary Member is \$10.00 annually to National Headquarter. Any additional charges to the Honorary Member would be up to the Local Department Auxiliary. Carried

Any discussion of grievances Local problem or claim concerning an individual with respect to her personal interest pertaining to he grievance Meeting will not be discussed outside the Grievance Hearing.

Change to Read:

Section Q: The Grievance Committee at the hearing shall then determine the degree of punishment and whether there shall be a suspension from the benefit Membership and if so, for how long on an expulsion. Any decision of grievance. Local problem or claim concerning an individual with respect to her personal interest pertaining to the Grievance Meeting will not be discussed outside of the Grievance Hearing.

Section R: Currently read: Any member whose membership is suspended or forfeited may appeal to the next highest level (Local Auxiliary to the Department Appeal Board). A letter shall be sent to the Local/Department President notifying her that the membership is suspended or forfeited.

Section S-Read: The member has the right to appeal in writing to the next level. (See Appeals Process Section 3)

Section S Change to read: On the Local Level a written document of the results will be sent by the Grievance Committee Chairman to all the members of the committee, along with the accused. Local and a copy sent to the Department within 30 days. Carried

On the Department Level a written document of the results will be sent by the Grievance Committee Chairman to all the member of the committee, the Department and a copy to National within 30 days. Carried

Section S: Would then become T, T would become U, U would become V.

Add: Section 2W: The decision of the Grievance Committee stands until a member file an appeal and the appeal hearing is held. Carried

Section Q—Read: The Grievance Committee at the hearing shall then determine the degree of punishment and whether they shall be a suspension from the benefit of membership and if so for how long: or an expulsion from membership. Any

discussion of grievances, Local problem or claim concerning an individual with respect to her personal interests pertaining to the Grievance meeting will not be discussed outside the Grievance Hearing.

Section S; Would become T, T would become U, U would become V.

Add Section 2W: The decision of the Grievance Committee stands until a member file an appeal and the appeal hearing is held.

Department Level; Trusteeship: Add a 3rd paragraph before the National Executive Board.

The Department Parliamentarian shall prescribe specific outcomes to be achieved by the Local Auxiliary which are clear, specific and measurable. The Trusteeship should be reviewed by the Department Executive Board at the Spring NEC and National Convention.

A Trusteeship shall be removed upon review by the National President and with the approval of the Executive Board at the Spring SEC or National Convention..

By-laws:

Article National Convention:

Section 13: Currently reads: The National President shall appoint a Convention Chairman two (2) years in advance of the National Convention from the Department of the Convention site. Said Chairman shall assume her duties as prescribe in the Convention Policy and Procedure Book, on September 1st.

Expenses for the Convention Chairman shall be provided for in the manual Convention budget.

Recommendation: Change National President to National President elect to correlate with working in Section 11, 12.

Section 14: Currently reads: The National President shall appoint at the Post Convention National Executive Committee meeting, Parliamentarian, VAVS Officer, Chairman for the Honors and Awards Committee, Junior AMVETS Coordinator, History/Scrapbook Chairman, Training Committee Chairman, as outline the these By-laws with the approval of the Executive Committee.

Recommendation: Change National President to National President elect to correlate with working in Section 11, 12.

Article V111: Headquarter Staff Section 1: The Headquarter Staff shall consist of such personal necessary to provide the services required to meet the needs of Headquarter operations. As defined by the National Executive Board. Perform such other duties as may be prescribed by the President, the Executive Board Committee, or as found in the Policy of AMVETS National Ladies Auxiliary and Headquarter Staff job description and procedure.

The Headquarter Staff shall (a) Consist of such personnel necessary to provide the services required to meet the needs of Headquarter Operation as defined by the Personnel Committee. Perform such other duties as may be prescribed by the President, Personnel Committee or as found in the Policy of AMVETS National Ladies Auxiliary and Headquarter Staff job description.

Announcement: Alaska sold the most tickets, 360 tickets. They will receive \$100.00.

Convention Rules

The Convention Rules listed in the Auxiliary Manual do not coincide with those listed in the Convention Book.

For example: Auxiliary Manual #14 reads: A general caucus of all candidates will be on Friday of National Convention at the time specified on the agenda.

#14 of the Convention Rules in the Convention Book read: Campaign posters or distribution o campaign material shall be not permitted in the convention room. Such posters and sign may be permitted as each individual hotel may designate. Campaign literature will be permitted outside of the convention meeting room and or distribution on Department tablets at least one-half (1/2) hour prior to the opening of sessions as printed in the convention agenda.

Recommendation: Change the current information listed under Convention Rules in the Auxiliary Manual to coincide with those listed in the convention agenda.
